Eight \$1,000 Scholarships Awarded

The WCTA Scholarship Committee recently reviewed 19 applications from area high school seniors. Eight students including Alicia Ahlf, Paul Funk, Luke Graham, Thomas Houle, Alana McKeever, Jordanna Schluttner, Kory Stave, and Markus Tolkkinen were awarded scholarships from WCTA. The scholarships were each valued at \$1,000.

Area high school seniors are invited every year to apply for the WCTA scholar-ship. Applying for a scholarship is very easy to do. The student can complete the entire scholarship application online, print them, and have them signed by their guidance counselor. This is the fifth year with the online format, which has been really helpful with keeping the applicants consistent and anonymous. The applicants choose from three or four topics for consideration when writing their essay. The scholarship committee reviews applicants based on their essay and community involvement. The scholarship's purpose is to recognize students who have contributed to the quality of life in the communities they live in and to assist them in their educational pursuits.

Only students whose parents or legal guardians are cooperative members at the time of the application are eligible to apply. Children of West Central Telephone's employees or board members are not eligible.
