At the time of this writing, we are still negotiating retransmission of several networks including KVLV, KXJB, KARE and KVRP. We have completed negotiations for WUCW and have received a fair rate; the other networks are again asking for huge rate increases. Unfortunately, this means we will most likely impose a rate increase as a result. Rest assured we will do our best to negotiate and keep the rates as low as possible.

We have added the following HD channels:

- Great American Country HD (GAC) on 310
- Fusion HD on 311

We have received multiple requests to add the Newsmax network over the last couple of months. The channel is now added to the Ultimate or Complete TV packages on channel 102. Scholarship Opportunities



As an investment in our youth, West Central Telephone is committed to the future of rural Minnesota. We are pleased to announce the following scholarship opportunities and invite all high school seniors to apply.

FRS College Scholarship Program

The FRS College Scholarship program provides \$2,000 and the sponsoring NTCA member company provides \$500 for a total of \$2,500. In addition to the FRS general scholarships, FRS has the following named scholarships:*

**Submitting one application is sufficient for eligibility of all available scholarships. Scholarships are completed online and must be submitted no later than March 5, 2021. For applications and guidelines, see your high school guidance counselor or visit www.FRS.org/student.*

WCTA Scholarship Program

High school seniors whose parents are cooperative members are encouraged to apply for one of eight scholarships in the amount of \$1,000 each. The application deadline is April 2, 2021. Our cooperative status allows us to fund our scholarship program in part through unclaimed capital credits.

Minnesota Telecom Alliance Foundation Scholarships

The MTA Foundation will award six scholarships to high school seniors graduating in 2021. Each scholarship will be in the amount of \$2,000. There are two types of scholarships this year:

- **One \$2,000 Telecom Scholarship** – To be eligible, applicants must be majoring in either Telecommunications or Information Technology (IT) at a university, college or technical college and be a Minnesota resident.
- **One of five \$2,000 General Scholarships** – To be eligible, applicants must be attending post-secondary education at a university, college or technical college, be a Minnesota resident, and the applicant's family must subscribe to at least one service from an MTA member company.

Once completed, the application must be printed and submitted to WCTA by February 19, 2021.

2nd Year or Beyond Scholarship

Current college students are urged to apply for a \$1,000 scholarship through the 2nd Year or Beyond Scholarship. Students who graduated from high school and are from any one of the telephone exchanges of WCTA currently attending 2nd year or beyond higher education are eligible. **Past scholarship winners are also eligible.** The application deadline is May 28, 2021.

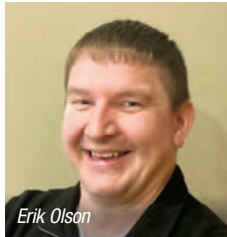

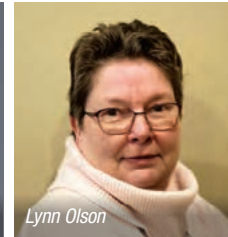

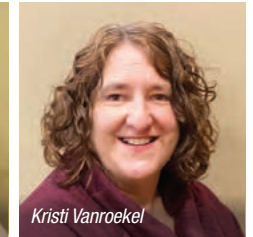
